The collection is catalogued, using current national standards for numbering, describing and recording collection data, according to the museum's Collection Policies and Procedures.

The collection is held for research, education and public exhibition in furtherance of public service, rather than for financial gain. The museum does not include either the cost or the value of its collection in the statement of financial position, nor does it recognize gifts of collection items as revenues in the statement of activities. Since items acquired for the collection by purchase are not capitalized, the cost of those acquisitions is reported as decreases in net assets in the statement of activities.
